By submitting the Photograph, I certify and warrant that the Photograph was taken and is owned only by me and that no other person may claim ownership of or any other rights or interest in the Photograph.

I am at least 18 years of age and competent to sign this release or, if the Entrant is under 18 years of age, the undersigned represents and warrants that he/she is a parent or legal guardian of the Entrant authorized to execute this Entry Form on behalf of the Entrant and to bind the Entrant to the terms and conditions set out in the Rules and the Entry Form.

Official Rules

1. All photographs must be taken within the Commonwealth of Virginia and submitted by a Contractor Member, Affiliate Member or Associate Member (collectively “Member”) of Virginia Asphalt Association (VAA).
2. Photographs must be taken by an employee or immediate relative (spouse/partner, child, grandchild or grandparent) of a Member in his or her individual capacity and not within the scope of his or her employment (the “Photographer” or “Entrant”). The Photographer must authorize the Member to submit the photograph and must sign the Entry Form in the designated space acknowledging his or her agreement to be bound by these Rules and the terms of the Entry Form.
3. This is strictly an amateur photographer contest. Photographs taken by professional photographers are prohibited.
4. If Photographer is under 18 years of age, the member employee must be Photographer’s parent/ or legally-appointed guardian and must sign the Entry Form on behalf of the minor Photographer.
5. A maximum of two photographs may be submitted per Member. A completed Entry Form must accompany each photograph.
6. All entries must be high-resolution photographs submitted in electronic format. The photo should represent the slogan “Asphalt King of the Road.”
7. Any changes to the original photograph are unacceptable and will disqualify the photograph from the contest.
8. Photographs may not include within them images that may infringe the intellectual property rights of or otherwise violate any rights of any third party. VAA reserves the absolute right to disqualify any photograph if VAA believes that the photograph may expose VAA or the Photographer to claims of misappropriation or infringement of intellectual property rights, violation of rights of privacy or publicity, defamation, breach of contract, or other legal liability.
9. The photograph, in its entirety, must be a single work of original material taken by the Contest Entrant. By entering the Contest, Entrant represents, acknowledges, and warrants that the submitted photograph is an original work created solely by the Entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.
10. Judging consists of two (2) rounds of evaluation. In round one, each judge in a panel of individuals who are not employed by or affiliated with a Member in the contest (“Judges”) will select ten (5) entries from among all eligible entries based on the following criteria (“Judging Criteria”): (1) Representation of Slogan (70%); (2) Photographic quality (20%); and (3) Genuineness and authenticity of the content (10%). The entries selected in round one will proceed to round two. In round two, the Judges will collectively select a First Place and Second Place Winner based on the Judging Criteria.
11. Winners will be chosen in September and will be notified by e-mail. Decisions of the Judges are final and binding. Winner is responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning a prize depend on the number of eligible entries received and skill of the entrant.
